



Permitted Use Policy

Purpose

The Oregon Podiatric Medical Association (“OPMA”) is approved by the Council on Podiatric Medical Education (CPME) as a provider of continuing education in podiatric medicine. This policy describes OPMA’s permitted use of educational presentations and materials prepared and delivered by instructors, content authors, and other contributors (collectively, “presenters”) in connection with OPMA continuing education activities, and documents the permission granted to OPMA to use such materials in compliance with applicable copyright laws, including the Digital Millennium Copyright Act (DMCA).

Grant of Permission

By participating as a presenter in an OPMA continuing education activity, the presenter grants OPMA the right to record and otherwise electronically preserve their lecture, presentation, and accompanying educational materials, and to use those materials in any written, oral, or electronic form, now known or later developed, for educational purposes consistent with OPMA’s mission. This grant includes the right to reproduce, distribute, display, and adapt the materials for OPMA’s educational programs, including in-person, virtual, hybrid, and on-demand or instructional media formats.

Attribution and Presenter Rights

OPMA will credit the presenter’s name and, where appropriate, image with the lecture and accompanying materials whenever the materials are used. Presenters retain ownership of their underlying intellectual property and may continue to use, modify, and distribute their own materials independently of OPMA.

Limitations on Use

OPMA shall not:

- sell, barter, transfer, or donate recorded or preserved materials to any third party;
- use the materials or recorded presentation for the benefit of any third party; or
- use the materials in any manner that would imply endorsement of a commercial interest or product.

OPMA’s use of the materials is limited to its educational purposes and the standards and requirements of CPME 720, Standards and Requirements for Approval of Continuing Education Providers in Podiatric Medicine.

Documentation of Copyright and Permission

OPMA documents ownership of the copyright, permission, or otherwise permitted use of materials in each continuing education activity. Presenters are responsible for ensuring that any third-party content (including images, figures, video, and excerpted text) included in their presentations is used with appropriate permission, license, or under fair use, and for providing OPMA with documentation of such permission upon request.

If a presenter incorporates copyrighted material owned by another party, the presenter agrees to:

- obtain any required licenses or written permissions in advance of the activity;
- provide proper attribution within the materials; and
- indemnify OPMA against claims arising from the unauthorized use of third-party content.

Patient Confidentiality

All materials submitted for use in OPMA continuing education activities must comply with the Health Insurance Portability and Accountability Act (HIPAA) and other applicable patient privacy laws. Identifying patient information must be removed from all presentations and handouts before submission.

Term

The permissions granted under this policy continue for so long as OPMA uses the materials for the educational purposes described above, subject to the limitations set forth in this policy and any separate written agreement between OPMA and the presenter.
